ORDER

This matter having come before the Illinois Board of Nursing of the Division of Financial and Professional Regulation of the State of Illinois, Division of Professional Regulation (hereinafter referred to as the 'Department') and the Illinois Board of Nursing, having made certain Findings of Fact, Conclusions of Law and a Recommendation to the Director of the Department; and the Department having complied with all required notices; and the time allowed for filing of a Motion for Rehearing before the Acting Director of the Department having now passed;

NOW, THEREFORE, I, JAY STEWART, DIRECTOR OF THE DIVISION OF PROFESSIONAL REGULATION of the State of Illinois, do hereby adopt the Findings of Fact, Conclusions of Law and Recommendation of the Illinois Board of Nursing in this matter.

IT IS THEREFORE ORDERED that the Certificate of Registration, License No. 041220467 heretofore issued to Mary Rose Veltri to practice as a Registered Nurse in the State of Illinois, shall be INDEFINITELY SUSPENDED for a minimum period of one (1) year. The suspension period shall begin as of the effective date of this Order.

IT IS FURTHER ORDERED that Respondent shall be fined in the amount of FIVE THOUSAND Dollars (\$5,000.00). The fine shall be due and payable to the Department within sixty (60) days of the effective date of this Order.

IT IS FURTHER ORDERED that Respondent hereby placed on notice that, if she violates any provisions of the Illinois Nursing Practice Act while disciplined, such information may be

presented by the Department during any hearing on the Petition for Restoration of Respondent's Registered Nurse license, Certificate No. 041220467. For at least one (1) year from the effective date of this Order, Respondent cannot file with the Department, a Petition seeking to restore her Registered Nurse license from a suspended licensure status.

IT IS FURTHER ORDERED that Mary Rose Veltri shall immediately surrender said Certificate of Registration and all other indicia of licensure to the Department of Financial and Professional Regulation of the State of Illinois. Upon failure to do so, the Department shall seize said Certificate of Registration.
