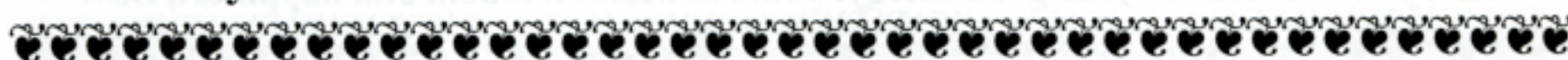

Dear GetWell Best Friends of Vivian Virginia & Tosca & Gregory!

GREETINGS! So many of you have been asking variations of one question: “HOW GOES THE BATTLE FOR DR. VETRANO & HER DAUGHTER & SON-IN-LAW GREGORY?” How it has gone is now ready to be told. Read on to be in on the story. You have already done so much. I hope you will be able to help a little further. The letter I recently sent out to their Best ROYL Friends follows:

August, 2006, marked troubled times for me and the outfit at ROYL. Since August, 2006, I have put in over 2,000 hours and 20 months helping to get The 2nd Edition of *The Live Food Factor* in print and ready for shipping to Health Seekers and book outlets around the world. I have braved genuinely hilarious misery getting an unpublished author and her self-proclaimed editor to understand why all the changes were needed from the 1st edition to the next. I doubt any book in history has gone through more massive changes from the 1st edition to the 2nd: well over 12,000 individual changes have been made — from a new cover to new chapters to single marks of punctuation and more powerful vocabulary, reorganization of existing information, new testimonies, and on and on and on! And, since August, 2006, Dr. Vivian Virginia Vetrano and her daughter and son-in-law — Dr. Tosca Haag and Dr. Gregory Haag — have been involved in their own misery — a lawsuit that was formally declared in November, 2006, and just settled last month.

While they have been listening to my misery stories on *The Live Food Factor*, I have been listening to their misery stories resulting from the lawsuit against ROYL. My work is now done on the book — the book is on the presses right now. We will have *The Live Food Factor* in late June. And the Vetrano/Haag lawsuit it also now done — with a settlement just made. But while I have been left with the FUN of sending out over 600 copies of “our new book” that over 200 GetWell Friends have ordered, the ROYL outfitters have been left high and dry with \$150,000 in lawyers’ fees and \$1,000,000 in a high interest loan, both yet to pay. We 2 outfitters and our friends have commiserated among ourselves and have been helping each other as much as we could the whole time — trying our best to ward off fears and to remain hopeful and cheerful in the face of adversity.
